



ORDINANCE NO. 2024-07-11-004

ORDINANCE GRANTING THE RECORDER'S REQUEST TO USE MONIES FROM THE RECORDER'S RECORDS PERPETUATION FUND TO SUPPLEMENT THE RECORDER'S 2025 BUDGET

By the affidavit contemplated by I.C. 36-2-7-10.2(b), the County Recorder has requested the sum of \$283,015, of the Recorder's Perpetuation Fund be used to supplement payment of the expenses of the Recorder's Office for the 2025 calendar year.

Pursuant to I.C. 36-2-7-10.2(c), upon receiving the Recorder's affidavit, the County Council may adopt an ordinance approving the Recorder's request.


The Recorder's affidavit is in proper form and content and the County Council wishes to grant the Recorder's request.

NOW, THEREFORE, IT IS ORDAINED AS FOLLOWS:

The request of the County Recorder asking the sum of \$283,015, of the Recorder's Records Perpetuation Fund be used to supplement payment of the expenses of the Recorder's Office for the 2025 calendar year is granted.

I, Deborah A. Wright, after first being duly sworn upon my oath, state as follows:


1. I am the duly elected Recorder of Kosciusko County, Indiana.

5. The RPF has a sufficient reserve, consistent with the recorder's plan, to capitalize the next technology or other records management upgrade necessary to fulfill the statutory purpose of the fund and the County Recorder's office.
6. I am requesting approval to use the RPF to specifically pay the salary and benefits for Chief Deputy 10076 and Recorder Deputies 10078 and 10079 for the year 2025, and the operating supplies and expenses for same year; the amount for said expenses totaling \$283,015.
7. This request is in accordance with the provisions set forth in I.C.36-2-7-10.2.


